The meeting was called to order by TH at 1:34. A quorum was present.

LR motioned to approve the agenda and the October minutes. GM seconded the motion. Agenda and minutes were approved unanimously.

#### **Public Comment**

#### **General Announcements**

Movement East, Movement West, and Movement Raleigh were approved by the Charter School Advisory Board to open in 2024.

We are looking to add Network positions to support scaling as we continue to grow. Looking for support with recruitment and finances.

Principal Gorham was on the Kelly Clarkson show where he met Ruby Bridges and was able to highlight all the amazing things we are doing here at Movement.

#### **Budget Updates**

Kyle Koots is serving as a consultant with Movement Schools. He met with Prestige and school teams to analyze budgets and is working to provide additional support and expertise to the finance committee.

State funds have been exhausted until the next installment drop happens usually in late Nov. early Dec. Local funds have started coming in on November reports.

Movement Schools has a \$1.2 Million reserve. TH led a discussion to provide a \$300,000 loan out of that reserve to Southwest. Board discussion was had around the process and material level that would trigger the process for future instances.



Finance committee will meet to further discuss and develop the process.

TH motioned to approve to transfer \$300,000 in reserved funds to Southwest to support operating cost. JT seconded.

# **Network Updates**

Jenika Mullen shared network updates. Schools are focused on going after Cycle 2 goals. Leaders are immersed in development and increasing content knowledge. Cycle 2 launches in 12 days. Focus this cycle is on creating incentives based on academics.
