The meeting was called to order by TH at 1:36. A quorum was present.

MD motioned to approve the agenda and the March minutes. LR seconded the motion. Agenda and minutes were approved unanimously.

School Finance - Lead by Prestige Finance Team

In 9th month of operations and should be sitting at 24.9% remaining

Eastland

Revenue - Percent remaining 26% Expenses - 27% remaining Projected Net Loss - \$70,000

Freedom

Revenue - Percent remaining 30% Expenses - 33% remaining Projected Net Loss - \$216,000

Southwest

Revenue - Percent remaining 28% Expenses - 26% remaining Net Loss \$766,000 Projected Net Loss - \$955,650

MC motioned for approval for updated school calendar, catering bid, teacher observation tool, EC policies and Guidelines for Northwest. JT seconded.

Contingency Planning for NW

- In the event that we had to shift locations we will still honor the transportation plan within 5 miles of the planned permanent location.
 - Bussing would go to and from temporary site using planned cluster stops from permanent location
 - If a location shift occurs a meeting will be scheduled with parents to explore additional transportation barriers and supports needed
- In talks with Aristotle Prep for possible rental but there are some potential space limitations
- Reached out to a church that has a current educational setup to discuss rentals
- Last option would be Movement Middle.
 - Discussion was had around the potential impact of having an additional 125 students at the middle school.
- GM will connect with JS to further discuss and plan for contingency
